

**SNOW EMERGENCY AND EMERGENCY PARKING ORDINANCE FOR THE TOWN OF ROXBURY, WISCONSIN**

**ORDINANCE NO. 2008-03**

**SECTION 1: EXISTENCE OF SNOW EMERGENCY.** Pursuant to the Town's authority under Wisconsin Statutes Chapters 166 and 349, the Town hereby declares that whenever there is a snowfall of four inches (4") or more during a twelve (12) hour period, a snow emergency shall exist in the Town.

**SECTION 2: TOWN CHAIRMAN MAY DECLARE SNOW EMERGENCY.** In circumstances other than those in section 1, the Town Chairman may determine that an emergency exists because of existing or threatened snow or ice conditions which necessitate the prompt removal of accumulations of ice and snow from Town roads and highways. The Town Chairman may by appropriate public media declare a snow emergency during which emergency snow parking regulations shall be in force as described below.

**SECTION 3: PARKING PROHIBITED DURING SNOW EMERGENCY.** It shall be unlawful for any person to park or cause to be parked any vehicle on any of the following Town roads, highways or streets during a snow emergency:

Parking on the above listed town roads, highways and streets may resume at the later of either a) the termination of the snow emergency, or b) 24 hours after the snow or precipitation has ceased and the Town road has been cleared.

**SECTION 4: TERMINATION OF EMERGENCY.** A snow emergency may be terminated by public announcement in the appropriate public media declaring the termination.

**SECTION 5: SIGNS AND POSTING.** The Town shall place appropriate "Snow Emergency Parking" signs on or along portions of the Town roads in section 3 above, to reasonable inform motorists of the parking regulations, and when they are in effect. The Town shall also place appropriate signs at or reasonably near the Town limits on all State and County Trunk Highways and connecting highways informing motorists that snow parking regulations may be in effect.

**SECTION 6: PLACING SNOW IN STREETS.** It is unlawful for any person to:

(a) Plow or otherwise remove accumulated snow from a private parking lot or driveway and deposit same on a Town road or right-of-way.

(b) Plow snow from a private parking lot or driveway and deposit same on a Town road or right of way in such a manner as to decrease the drivable width of any such Town road or any other private driveway.

**SECTION 7: INTERFERENCE WITH SNOW REMOVAL.** It is unlawful for any person to obstruct, harass, prevent or otherwise interfere with any employee of the Town or County engaged in snow removal service or to obstruct, cause damage to or otherwise interfere with any Town owned, leased or contracted vehicle used in conjunction with snow removal services.

**SECTION 8: Penalty.** Any person violating this Ordinance shall be liable for a forfeiture of between \$10.00 and \$200.00 for each offense and the costs of prosecution herein. The bond amount for the first such infraction shall be \$25.00 plus costs. The bond amount for any second or additional such infraction within a 12 month period shall be \$50.00 plus costs. Each day a person violates this ordinance shall constitute a separate and distinct offense and the violator will be subject to a separate forfeiture for each day of violation hereof.
