NOTICE IS HEREBY GIVEN THAT A SPECIAL TOWN MEETING OF THE TOWN OF ROXBURY, DANE COUNTY, WISCONSIN, WILL BE HELD AT THE TOWN HALL LOCATED AT 7167 KIPPLEY ROAD, SAUK CITY, WISCONSIN, ON THE 1<sup>ST</sup> DAY OF DECEMBER, 2020 AT 7:00 P.M. FOR THE FOLLOWING PURPOSES:

**Ervin Breunig called meeting to Order @ 7:00 p.m.**

**Present were Ervin Breunig, Nick Ganser, Mike Bradley, Nanette Backeberg and Lisa Meinholz**

1. To establish the compensation for elected town officers pursuant to s. 60.10(1)(b)1, Wis. Stat. Approved changes will not become effective until the start of the new terms in April 2021. **Mike Bradley made a motion to approve yearly annual wage of \$6,000 for the Town Chairman and \$4,000 for the Town Supervisors along with an increase of per diem meetings to \$45. 2<sup>nd</sup> by Nick Ganser. YES – Ervin Breunig, Nick Ganser, Mike Bradley. No - 0**
2. To approve the 2020 total town tax levy to be collected in 2021 pursuant to s. 60.10(1)(a), Wis. Stat. – **Nick Ganser made a motion to approve the 2020 Town Tax Levy in the amount of \$586,018. 2<sup>nd</sup> by Mike Bradley. Vote of Town Elector was 5 yes and 0 no votes.**
