4. Verification of Public Notice – Notice was posted on Town Website and Outdoor Bulletin Board

Also, the fruit/pumpkin season will be ending soon and this should fix itself.
9. Mussen Road Discussion – Discussion with MSA, Town of West Point, Town Patrolman regarding opening Mussen Road. At this point it is still under water but MSA is going to go take a look to see how much of the road is totally gone. Town needs to wait to see what is happening with the mitigation project that has been taken over by a Technical Committee. Also, discussed the issue with Schoepp Road and what needs to be done to open the road. It is not an easy fix and the DNR will more than likely be in control of possibly what happens with both of these roads.
