Mussen Road Discussion- Brian Kehrl from MSA reported that he went over to investigate Mussen Road and found that there is erosion on several locations that make the road only 1 lane wide, the road is above water except for about 300 ft., and some of the east face has eroded the rip rap. There is already an plan from 2010 drawn up for raising Mussen Rd. Brian estimates that the cost could be upward of \$800,000. DNR will also need to be involved in permitting for this project. The road is too dangerous for the town to open on a temporary basis.
10. Patrolman Report - Dave asked about hiring Tree service to cut down trees around the township. Mike Bradley is going to look into how some other town bid this out.
