The town will put up no parking signs by the bridge between On the Rox and the Town Garage. The town will not put no parking signs on the roadway as parking is permitted on town roads and easements.
- 11. Patrolman Report Dave reported on signage at Mussen Road and Schoepp Road. Road Closed signs will be posted at both ends of the road and documented for Town liability issues. Also, no more signage will be done at the boat landing on Fish Lake Road for "slow no-wake, motors, etc."
